ANY OFFER TO SELL BY THARANCO LIFESTYLES LLC, D/B/A GREG NORMAN COLLECTION (HEREIN: "GREG NORMAN COLLECTION") AS WELL AS ANY ACCEPTANCE BY GREG NORMAN COLLECTION OF A PURCHASER'S ORDER IS EXPRESSLY MADE CONDITIONAL UPON PURCHASER'S ASSENT TO THESE TERMS AND CONDITIONS OF SALE AND NO OTHERS. PURCHASER'S TAKING DELIVERY OF ANY PRODUCT OR PAYMENT OF ANY INVOICE SHALL BE CONCLUSIVE EVIDENCE OF SUCH ASSENT.

Orders: All orders are subject to acceptance by an authorized official of Greg Norman Collection at Greg Norman Collection's Corporate Headquarters Office. Acceptance by Greg Norman Collection of an order shall be deemed to occur only upon the tendering of delivery of the products that are the subject of such order to the carrier for delivery to Purchaser. Acceptance by Greg Norman Collection is limited to the terms stated herein and in the Greg Norman Collection Authorized Retail Dealer Agreement. Such terms and conditions shall control irrespective of any inconsistent, different or additional terms and conditions, whether printed or otherwise, set forth in any communication from Purchaser to Greg Norman Collection, including without limitation in any Purchaser purchase order, confirmation, routing guide or manual revision and Greg Norman Collection hereby rejects any such inconsistent, different or additional terms or conditions unless otherwise specifically agreed to in writing by Greg Norman Collection. Without limiting the foregoing, Greg Norman Collection further rejects terms and conditions inconsistent with, different from or additional to those contained herein which are contained on any website of Purchaser for which access is conditioned on acceptance of such terms and conditions.

A functional acknowledgment sent on receipt of an electronic order does not constitute acceptance of electronic data interchange orders (for more information and further detail regarding the placement of electronic data interchange orders, see the Greg Norman Collection Electronic Data Interchange Trading Partner Agreement).

Minimum Order Size: Any embroidered orders accepted for less than twelve (12) units shall be subject to an upcharge. There are no upcharges for blank orders for less than twelve (12) units. For more details, contact your sales representative..

Prices: No employee, Greg Norman Collection sales representative or any other party other than an officer of Greg Norman Collection is authorized to alter Greg Norman Collection's pricing and other terms and conditions of sale. All prices are subject to change without notice. Orders will be billed at prices prevailing at the time of order as reflected on Greg Norman Collection's then

current price list. Greg Norman Collection will not recognize any terms outside of its standard programs except as specifically agreed in writing by Greg Norman Collection. The amount reflected in a Greg Norman Collection invoice will be deemed accepted and binding upon Purchaser unless Purchaser notifies Greg Norman Collection in writing of a dispute within thirty (30) days of the date of the invoice.

Payment Terms: Unless otherwise stated on the invoice, terms of payment shall be net sixty (60) days from the invoice date. Purchaser shall not set off against or deduct from any amounts due to Greg Norman Collection hereunder all or any part of any amounts owed or alleged to be owed by Greg Norman Collection to Purchaser. Chargebacks will not be accepted by Greg Norman Collection unless agreed to in writing between Greg Norman Collection and Purchaser. A service charge of 1.5% per month will be charged on all past due invoices plus costs of collection (including but not limited to actual attorneys' fees and disbursements). There are no discounts to customers having an overdue balance.

Each order placed by Purchaser and accepted by Greg Norman Collection shall be considered an independent transaction, and payment therefor shall be due accordingly. If Greg Norman Collection, in its sole discretion, at any time is unsatisfied with Purchaser's financial responsibility or credit worthiness, or if Greg Norman Collection feels it needs further assurance that Purchaser will pay for outstanding orders, Greg Norman Collection shall be entitled to require Purchaser to pay for its orders on a cash-in-advance basis. If Purchaser is in default under any agreement with Greg Norman Collection, or fails to comply with any written rule or policy of Greg Norman Collection, Greg Norman Collection shall have the right, without prejudice to any other legal remedy, of canceling all outstanding orders. Until payment of all obligations of Purchaser to Greg Norman Collection is received in full, Greg Norman Collection shall retain its purchase money security interest in the goods covered by an order and the proceeds thereof, and Purchaser hereby authorizes Greg Norman Collection to file all and any documents and to give all and any notices which may be necessary or appropriate to protect and perfect and give priority to Greg Norman Collection's security interest therein.

Audit Claims: Greg Norman Collection invoices received and retained by Purchaser will be deemed accepted, will be conclusive and binding upon Purchaser (excepting manifest error), and will not be subject to any audit claim by Purchaser unless Purchaser notifies Greg Norman Collection in writing of its specific objections within thirty (30) days after receipt of such invoice is due.

Delivery: All warehouse orders are shipped F.O.B. shipping point (Greg Norman Collection loading dock). Container dropship orders are shipped F.O.B. port of entry. All container dropship Purchasers assume ownership of goods upon notification to Purchaser's designated carrier of availability of the container for pickup (by facsimile delivery of the delivery order therefor, telephone notification or such other method as is customary for presentation) within the shipping window indicated in the invoice or as otherwise agreed between the parties. Unless otherwise directed in writing by Purchaser, Greg Norman Collection will use the carrier designated by Greg Norman Collection. Purchaser is responsible for all payments due to the carrier. Purchaser assumes all risk of loss upon delivery of products by Greg Norman Collection to Purchaser's carrier in the case of warehouse orders and to the bailee in the case of container orders. Greg Norman Collection is under no obligation to insure shipments unless specifically requested by Purchaser and then only at Purchaser's expense and valuation.

Greg Norman Collection reserves the right to make shipments in installments within the shipping window indicated on the purchase order. Greg Norman Collection will attempt to meet delivery schedules requested by Purchaser. However, all delivery indications are estimates only. In no event will Greg Norman Collection assume any liability, consequential or otherwise, as a result of Greg Norman Collection's failure to deliver product in accordance with indicated delivery schedules. Delivery of part of an order does not obligate Greg Norman Collection to make further deliveries, and partial deliveries will be billed when made.

Changes in Orders: Changes in orders will be considered only (i) within thirty (30) days of order submission in the case of container orders, or (ii) no later than forty-five (45) days prior to the first shipment date indicated on the order in the case of warehouse orders.

Order Termination by Purchaser: Warehouse orders may be cancelled by the Purchaser only upon written authorization from Greg Norman Collection's Corporate Headquarters Office and only will be considered if requested no later than forty-five (45) days prior to the first shipment date indicated on the applicable order. Cancellations exceeding 10% of any monthly future bookings will result in loss of discount.

No Transshipments: Greg Norman Collection sells only directly to selected retail outlets for resale by them only to end users at physical retail locations of the Purchaser as approved by Greg Norman Collection. Proposed sale at any new retail outlet requires advance written

approval from an authorized Greg Norman Collection official of Greg Norman Collection's Corporate Headquarters Office. Resale or transshipment of merchandise to an unauthorized location or to another business is expressly prohibited, violates the terms and conditions of sale and may result in cancellation of existing orders and/ or termination of Purchaser's business relationship with Greg Norman Collection. It is understood and agreed that said prohibition of transshipment includes without limitation sales via the Internet or other media, fulfillment of sales originating from electronic media, as well as sales through mail, direct order or catalogues, unless expressly authorized in writing through a separate contractual agreement with Greg Norman Collection. Purchaser acknowledges and agrees that Greg Norman Collection is the sole authorized distributor of Greg Norman Collection products in the United States and Purchaser will not purchase Greg Norman Collection products from any source other than Greg Norman Collection.

Change in Ownership: The sale of or a partial, majority, or total change in the ownership in Purchaser or any of Purchaser's approved retail outlets, or all or a substantial portion of Purchaser's assets, shall be deemed an assignment and shall require the written consent of Greg Norman Collection, in its sole discretion. As a condition precedent to any consent by Greg Norman Collection to such change in ownership or assignment, the new owner(s) must apply to Greg Norman Collection for approval as an authorized dealer and Purchaser will merchandise until the application is approved in writing by Greg Norman Collection's Corporate Headquarters Office.

Representative Amount of the Line: Greg Norman Collection sells only to retail outlets which carry a representative amount of the line as deemed appropriate by Greg Norman Collection in light of the type of retail outlet, the status of Greg Norman Collection's line or lines of merchandise, and marketing conditions. Failure of a retailer to do so contravenes the terms and conditions of sale and may result in cancellation of existing orders and/or termination of Purchaser's business relationship with Greg Norman Collection.

Distribution Channels: Greg Norman Collection reserves the right to limit the distribution of some product lines or segments to certain selected distribution channels.

Design Changes: Greg Norman Collection reserves the right to discontinue product lines and to make changes offered in products at any time.

Allocations: Acceptance of orders and shipments are subject to allocation by Greg Norman Collection in times of product shortages in response to factors deemed most appropriate by Greg Norman Collection at the time.

Merchandising of Products: Purchaser agrees to (a) provide prompt, courteous service to its Greg Norman Collection consumers using personnel trained in the selling and servicing of golf products and Greg Norman Collection products in particular; and (b) merchandise Greg Norman Collection products consistent with guidelines established by Greg Norman Collection from time to time, including with respect to the in-store display of Greg Norman Collection products.

Shortages: All claims for lost or damaged shipments (a) with respect to warehouse orders, must be made directly to the delivering carrier, and (b) with respect to containers, must be made in accordance with Greg Norman Collection's claims policy, a copy of which is available on request. Shortages due to packing errors must be reported to Purchaser's Greg Norman Collection Account Service Representative in New York, New York within fifteen (15) days of receipt in the case of shortages in cartons and within thirty (30) days of receipt in the case of concealed shortages.

Return Goods Policy: All returns, including the product assortment and quantity to be included as a return, are subject to pre-authorization by Purchaser's Greg Norman Collection Account Service Representative. Defective and return to stock items must be authorized and returned separately.

Upon approval by Greg Norman Collection, a Return Authorization Number and, if requested, Label, which must be clearly affixed to the outside of the carton will be issued to the Purchaser. Returns not carrying the Greg Norman Collection Return Authorization Number will be refused delivery by Greg Norman Collection and will be returned to the Purchaser. Merchandise must be returned in the same salable condition as received. Credit will not be issued for any product items or quantities other than as specifically included in the pre-authorization.

All returns must be shipped to Greg Norman Collection in accordance with Greg Norman Collection's Routing Guide for return freight. With defective merchandise, the Purchaser's account will be credited at full value. First quality returns will be credited to the Purchaser's account at full value less a fifteen percent (15%) restocking charge. Shipments refused by the Purchaser will be credited at full value if the shipment error is by Greg Norman Collection. Shipments refused for reasons not attributable to Greg Norman Collection will be credited at full value less fifteen percent (15%) restocking charge. Greg Norman Collection reserves the right to assess a charge on return shipments for the removal of any pre-ticketing.

Customer Routing and Logistic Requirements: Greg Norman Collection will not be bound to terms, directives or requirements set forth by Purchaser through Routing and Logistic Guides unless Greg Norman Collection has agreed in writing to such terms, directives or requirements. In addition, Purchaser may incur charges for value added services (labeling, ticketing, and special packaging). Routing and Logistic Manuals should be directed to the Compliance Department located at Greg Norman Collection's corporate headquarters office.

Limited Warranty: Greg Norman Collection warrants that its products, at the time of shipment, are free from defects in workmanship and materials. THE WARRANTY DESCRIBED IN THIS PARAGRAPH SHALL BE IN LIEU OF ANY OTHER WARRANTY, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, ANY IMPLIED WARRANTY OF MERCHANTABILITY, NON-INFRINGEMENT OF THIRD PARTY RIGHTS OR FITNESS FOR A PARTICULAR PURPOSE.

Purchaser's remedies are exclusively limited to replacement of or credit for any defective product (at the option of Greg Norman Collection) but such replacement or credit shall be made only if the Purchaser follows the terms and conditions set forth herein under the "Return Goods Policy" section.

Limitation of Liability: GREG NORMAN COLLECTION ASSUMES NO LIABILITY EXCEPT AS EXPRESSLY PROVIDED IN THESE TERMS AND CONDITIONS AND IN NO EVENT WILL GREG NORMAN COLLECTION BE LIABLE FOR LOSS OF PROFITS, INTERRUPTION OF BUSINESS OR ANY OTHER SPECIAL, PUNITIVE, EXEMPLARY, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, WHETHER ARISING IN CONTRACT, IN TORT, UNDER WARRANTY OR OTHERWISE.

Force Majeure: If a delivery date is specified, that date will be extended to the extent that delivery is delayed by reason of fire, flood, war, riot, strike, attack, natural disaster, or any other event beyond Greg Norman Collection's reasonable control and if, as a result of such a delay, the goods ordered are unavailable, Greg Norman Collection may substitute comparable goods; provided, however, that no event of Force Majeure shall excuse payment of any past-due invoice.

General: This contract shall be construed and enforced in accordance with the laws of New York, without reference to its conflicts of law rules that would apply the laws of any other jurisdiction. The parties hereby agree that the New York courts (state and federal) located in New York County will have exclusive jurisdiction of any controversy arising out of this agreement between Purchaser and Greg Norman Collection, and the parties hereby irrevocably consent to the jurisdiction of those courts. Both Greg Norman Collection and Purchaser waive their right to jury

trial in any controversy or court action between them. Any action for breach of contract must be commenced within one (1) year from the date of the delivery of the goods. Purchaser's rights under this contract may not be assigned, transferred, or sold by Purchaser without the prior written consent of Greg Norman Collection, which may be withheld in Greg Norman Collection's sole discretion, and any attempted assignment in contravention with the foregoing will be void. Greg Norman Collection may assign this contract to a parent, subsidiary, or affiliated firm, or to another entity in connection with the merger, sale or transfer of all or substantially all of its business. Subject to these restrictions, the provisions of the contract shall be binding upon and inure to the benefit of the parties, their successors, and permitted assigns. Terms and conditions are subject to change by Greg Norman Collection without prior notice. The Greg Norman Collection Authorized Retail Dealer Agreement and these terms and conditions of sale constitute the entire agreement between the parties with respect to the subject matter hereof and supercede all previous agreements or understandings between the parties with respect thereto. No additions to, deletion from, or modification of any of the provisions herein shall be binding upon Greg Norman Collection unless made in writing and signed by a duly authorized representative of Greg Norman Collection, the terms and conditions herein being final, complete and exclusive statement of terms of agreement between Greg Norman Collection and Purchaser.
